Sightview myCare Portal Version 4.0 is a patient communication system designed to support healthcare professionals in ophthalmology and optometry in outpatient office and ambulatory environments. It is intended for use with Sightview EHR Health IT modules, and it allows users to perform a wide range of functions such as:

- Doctor to Patient, Patient to Doctor Secure Messaging.
- Provide patients with access to online health summaries.
- Collect Patient Generated Health Data.
- Automated reminders and Follow-up.
- Provide application access functionality (patient selection and all data requests) for authorized users of the myCare Portal version 4.0. myCare Portal does not include Standardized API for Patient and Population services.
- EHI Export of single patient and all patients' data: Requires use of the Sightview CEHRT to perform export requests.

Types of Costs or Fees and Additional Types of Costs or Fees

This certified product-version may require additional monthly costs to support transition of care summaries (170.315.b.1) when more than a HISP mailbox is required and online patient service (170.315.e.1). A Sightview third-party PMS and the Sightview EHR is required to maintain patient demographics and health records.
